If the estimated completion date is delayed by uncontrollable events, we'll keep you informed.
- Orders are limited to colors, styles, and leathers as shown on our website.
- We do not customize or monogram.
- If materials are not available, we'll contact you and determine if you want to cancel the order or order a different bag.
- Payment is due upon completion of the bag but prior to shipment.
- Shipping costs are included in the price of your bag.
- If you're not satisfied with your bag, return it within 10 business days of receipt and your money will be refunded or apply it to a different bag.
- If a flaw develops in your bag that is the result of construction, send it back we'll fix it.
- Montana Bison and Leather is not responsible for damage due to friction, scratching, stretching, overloading, fading, and other use related issues. Please see the Leather Care section of this website for ways to prevent use related issues.
